ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

SUMMARY

Offer Price and Net Proceeds

- The Offer Price has been determined at HK\$0.75 per Offer Share (excluding brokerage of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$0.75 per Offer Share, the net proceeds from the Global Offering to be received by the Company, after deduction of underwriting fees and commissions and estimated expenses payable by the Company in connection with the Global Offering, is estimated to be approximately HK\$79.0 million (equivalent to approximately RMB65.6 million). The Company intends to apply such net proceeds in accordance with the purposes set out in the section headed “Future plans and use of proceeds” in the Prospectus.

Applications under the Hong Kong Public Offering

- The Hong Kong Public Offer Shares initially offered under the Hong Kong Public Offering have been very significantly over-subscribed. At the close of the application lists at 12:00 noon on Friday, 5 March 2021, a total of 87,305 valid applications have been received pursuant to the Hong Kong Public Offering (i) on **WHITE** and **YELLOW** Application Forms; (ii) through giving **electronic application instructions** to HKSCC via CCASS; and (iii) to the **White Form eIPO** Service Provider through the **White Form eIPO** service for a total of 4,244,420,000 Hong Kong Public Offer Shares, representing approximately 214.36 times of the total number of 19,800,000 Hong Kong Public Offer Shares initially available for subscription under the Hong Kong Public Offering. A total number of 9,964 Shareholders have been allocated Offer Shares under the Hong Kong Public Offering, 9,784 of which have been allocated one board lot of Shares.
- As the over-subscription of the Hong Kong Public Offering is more than 100 times, the reallocation procedures as described in the section headed “Structure of the Global Offering — The Hong Kong Public Offering — Reallocation” in the Prospectus have been applied, and 79,200,000 Offer Shares initially available under the International Placing have been reallocated to the Hong Kong Public Offering. As a result of such reallocation, the final number of Offer Shares available under the Hong Kong Public Offering has been increased to 99,000,000 Offer Shares, representing approximately 50% of the Offer Shares initially available under the Global Offering (prior to any exercise of the Over-allotment Option), being allocated to 9,964 successful applicants under the Hong Kong Public Offering.

International Placing

- The Offer Shares initially offered under the International Placing have been slightly over-subscribed, representing approximately 1.14 times of the total number of International Placing Shares initially available under the International Placing. Taking into account the reallocation of 79,200,000 Offer Shares from the International Placing to the Hong Kong Public Offering, the final number of Offer Shares under the International Placing is 99,000,000 Offer Shares, representing 50% of the Offer Shares initially available under the Global Offering (before exercise of the Over-allotment Option). A total number of 222 placees have been allocated Offer Shares, 79 of which have been allocated with five board lots of Shares or less and in aggregate have been allocated 1,025,000 Offer Shares under the International Placing, representing approximately 35.59% of the total number of placees and approximately 1.04% of the total number of International Placing Shares, respectively.

The Directors confirm that the International Placing is in compliance with the Placing Guidelines. None of the Sole Sponsor, the Joint Global Coordinators, the Joint Bookrunners, the Joint Lead Managers, the Underwriters and their affiliated companies and connected clients (as defined in the Placing Guidelines) has taken up any Offer Shares for its own benefits under the Global Offering. The Directors confirm that (a) no placee will, individually, hold more than 10% of the enlarged issued share capital of the Company immediately after the Global Offering, hence, there will not be any new substantial shareholder (as defined in the Listing Rules) of the Company immediately after the Global Offering; (b) the three largest public shareholders of the Company do not hold more than 50% of the shares in public hands at the time of Listing in compliance with Rules 8.08(3) and 8.24 of the Listing Rules; (c) there will be at least 300 Shareholders at the time of the Listing in compliance with Rule 8.08(2) of the Listing Rules; (d) the number of Shares to be held by the public will satisfy the minimum percentage prescribed by Rule 8.08(1)(a) of the Listing Rules; (e) none of the Offer Shares subscribed by the placees and the public has been financed directly or indirectly by any of the Directors, chief executive of the Company, Controlling Shareholders, substantial Shareholders or existing shareholders of the Company or any of its subsidiaries or their respective close associates; and (f) none of the placees and the public who has subscribed the Offer Shares is accustomed to taking instructions from any of the Directors, chief executive of the Company, Controlling Shareholders, substantial Shareholders or existing shareholders of the Company or any of its subsidiaries or their respective close associates in relation to the acquisition, disposal, voting or other disposition of Shares registered in his/her/its name or otherwise held by him/her/it.

Over-allotment Option

- The Company has granted the Over-allotment Option to the International Underwriters, which is exercisable by the Joint Global Coordinators on behalf of the International Underwriters pursuant to the International Underwriting Agreement at any time within 30 days from the last day for the lodging of applications under the Hong Kong Public Offering, to require the Company to allot and issue up to an aggregate of 29,700,000 additional Shares, representing not more than 15% of the Offer Shares initially offered under the Global Offering, at the final Offer Price to cover over-allocations in the International Placing. Based on the Offer Price of HK\$0.75 per Offer Share, the net proceeds from the Global Offering to be received by the Company (before any exercise of the Over-allotment Option), after deduction of underwriting fees and commissions and estimated expenses payable by the Company in connection with the Global Offering, is estimated to be approximately HK\$79.0 million (equivalent to approximately RMB65.6 million).
